Attendance of shareholders having one third (1/3) or more of the voting rights of shareholders entitled to exercise voting rights and vote for approval of a majority of the voting rights of those shareholders present at the meeting

(Proposal 5)

Vote for approval of a majority of the voting rights of those shareholders present at the meeting who are entitled to exercise voting rights

- (Note 2) The number of voting rights exercised on the day of the meeting (B) shows the number of the voting rights exercised in the form of "confirmation of approval or disapproval of the proposal" which the shareholders present at the meeting of the day of the meeting submitted. As a result, the number of shareholders from whom the said form is collected is 2,397 persons and the rate of such collection is 99.83%.
- (Note 3) When it is impossible to distinguish whether the vote cast shows approval or disapproval, the said vote is counted as an abstention.
- (Note 4) The percentage rates of votes are rounded off to the second decimal place.
